It is our pleasure to offer you an appointment as a Postdoctoral Fellow in the Department of Mathematics & MS2Discovery Research Institute within the Faculty of Science. This position is established to work with Dr. Roderick Melnik on the project entitled "Mathematical and computational modelling of low dimensional nanostructures and biological systems at the nanoscale and multiscale levels."

This is a full-time position for the period December 1, 2016 with the anticipated end date of November 30, 2017. The appointment may be subject to renewal. Your annual salary will be \$35,400 plus 4% in lieu of benefits. Your duties will be innovative research into coupled effects in low dimensional nanostructures and biosystems, including theoretical analysis and computations (using M2NeT facilities and Sharcnet); in addition you are expected to work as a team member, contributing to this field through publications and professional presentations.

As per the Postdoctoral Fellow Handbook, you will be entitled to 2 weeks vacation per year with salary and benefits. Vacation must be taken during the year in which it is earned and will not carryover.

Mandatory payroll deductions including income tax will apply. You will be paid in accordance with the University pay schedule, on a bi-weekly basis (see the bi-weekly pay schedule here: http://legacy.wlu.ca/page.php?grp_id=2459&p=11102). Your annual salary will be subject to applicable deductions and remittances, including deductions for certain costs of the benefits in which you will participate, and mandatory government deductions, including income tax, Canada Pension Plan contributions and Employment Insurance premiums. If during the term of this employment you wish to terminate employment, you may do so by providing two weeks' written notice to me. The University may terminate this employment contract at any time for cause without notice or payment in lieu of notice. Furthermore, the University may terminate this employment contract at any time and for any reason by providing you with only the minimum amount of written notice required by the *Employment Standards Act, 2000 ("ESA")*, or by paying you the

minimum amount of termination pay in lieu of notice or a combination of both, as well as paying severance pay and all other outstanding entitlements, if any, owing under the ESA. You agree that this notice, or notice and payments, fully satisfies the University's notice and severance obligations upon termination of your employment, whether arising under the ESA, common law, or this agreement. This term of employment with the University shall continue during any continuing, or further employment, irrespective of position, with the University unless expressly provided otherwise.

The offer of appointment is conditional on you meeting all Canadian immigration requirements to enter and work in Canada. This temporary appointment consistent with the terms of the International Mobility Program and is subject to the appropriate approvals being given by Citizenship and Immigration Canada (CIC). As a Postdoctoral Fellow, the University is exempt from the requirement of a Labour Market Impact Assessment confirmation under exemption code "C44". You are required to obtain a temporary work permit in order to enter the country, to legally begin and maintain the position.

You also may need to obtain a visitor visa and/or electronic Travel Authorization (eTA) before entering Canada by air. It is your responsibility to ensure that you are legally entitled, pursuant to CIC's requirements, to work at Laurier. If you are unable to do so on or before your appointment start date, this offer and any acceptance of it by you will be null and void unless a written deadline extension is provided by the University.
