The committee members also observed during the presentation of his case by Kashish he was not so polite about his seniors while referring the names of his senior students. The members agreed that he requires to being polite in his communication while talking to his seniors. However, the complaint of Kashish about Raghav and Sonakshi has were found correct.

- 2. Raghav Bansal: He has agreed to the fact that he was rude with Kashish and tried to joke on his name on the night of 4th August. The incident happened while a meeting was called upon by the senior students of Junior students to discuss about the ongoing Kabbadi Competition "Le Panga" in the campus. Resident Assistant of Boys Hostel-1 Prakhar (RA) was present while the seniors were talking to their Juniors. The act of Raghav was directly linked to the grudge he carries in his mind about Kashish because of his comment in the gym.
- 3. Sonakshi Jhanwar: Her complaint about the Kashish's intolerant behavior and bad comment was found not true as it was her assumption that Kashish has tried to humiliate the girls dancing in the IM Amphi theatre on the evening of 3rd August, 2018 by clapping at the end of dance and when asked by the seniors to leave the room Kashish has told "Hum Jaye Itna hi tha Kya". Otherwise there was never a direct face to face conversation or talk happened between Kashish and Sonakshi and her complaint about continuous abuse by Kashish to her found to be false. The committee felt, she might have put

written complaint just to support his friend Raghav.

Committee recommendation

The members felt that this is act of misbehavior by Kashish towards his Seniors and the same was reciprocated by the Seniors. The committee members have decided that:

- 1. Each one of them to apologize to each other for their misbehavior.
- 2. A warning letter to each one of them for the harsh action by the University in future if such incident is repeated.
- 3. All three students (Kashish, Raghav & Sonakshi) be counselled by their mentors for using appropriate words during communication.

Minutes of the Meeting of Discipline Committee held on February 27, 2017

The third meeting (Session 2016-17) of the Discipline Committee was held in the faculty longue, IM Block on February 27, 2017 at 5:00 PM to discuss the following case of indiscipline.

Case-07: On February 26, 2017, students of the Institute of Engineering and Technology i.e. Robin Singh, B.Tech (Branch: Mechanical Engineering) VI Semester and Siddhant Jain B.Tech (Branch: Computer Science Engineering) VI Semester quarreled and fought with each other in boys hostel-I, JKLU.

Findings:

(i) As per complaint of the Mr. Siddhant Jain, Students of B. Tech (CSE) semester-VI, Mr. Robin Singh, Students of B. Tech (ME) semester-VI attacked him in his room-505 due to which he i.e. Mr. Siddhant

(ii) Mr. Siddhant Jain mentioned that he was coordinator for committee of Trophy in SPARDHA 2017, a national level sports festival of JK Lakshmipat University, Jaipur. The trophies, left after valedictory function of SPARDHA 2017, were kept by Mr. Siddhant Jain and Mr. Sandeep Kumawat (2016BTechCSE016) in the room of Mr. Yashveer Inda, Student Core coordinator.

(iii) When Mr. Yashveer Inda and Mr. Robin Singh (Student Core coordinators) came to know that one trophy is missing, they asked Mr. Sandeep Kumawat. Mr. Sandeep Kumawat told that Mr. Siddhant

Jain kept one trophy with him. (iv) Thereafter Mr. Yashveer Inda and Mr. Robin Singh (Student Core coordinators) went to Siddhant Jain's room with Aaditya Tripathi (2014BTechCSE024) to ask about the lost trophy and closed the door from inside. Mr. Siddhant Jain accepted that he kept one trophy with him from the cartoon of the trophies and supposed to take permission from Faculty coordinator next day.

(v) Mr. Ribin Singh and Mr. Siddhant Jain had heated conversation and exchanged bad words. They quarreled and fought with each other as a result Mr. Siddhant Jain got injured. He got hairline fracture in his nose due to which he started bleeding heavily. At early stage, Mr. Yashveer Inda and Mr. Aaditya Tripathi didn't get involved in their interaction but later on they stopped fighting of Mr. Ribin Singh and Mr. Siddhant Jain.

(vi) Faculty, staff and some students of our University took Siddhant Jain to hospital and got required treatment as he was bleeding heavily.

(vii) Mr. Siddhant Jain was scared and called Police for further necessary action. Police came to the University and instructed not to get involved in such issue again. Mr. Siddhant mentioned that he didn't logged the FIR at Police Station against anyone.

(viii) Next day on February 27, 2017, Parents of Mr. Siddhant Jain & Mr. Robin Singh came to the University campus and counselled them not to get involved in such affairs and forgive to each other.

(ix) Thereafter, Mr. Siddhant Jain and Mr. Robin Singh had withdrawn their complaint for further process and action of the Discipline committee, JKLU.

Conclusions:

- (i) Mr. Siddhant Jain accepted that he kept one trophy without prior permission of faculty core coordinators and students core coordinators.
- (ii) Mr. Robin Singh accepted that he should have complained to faculty coordinator of SPARDHA 2017 if he was having any issue regarding the trophy rather than having fight with Mr. Siddhant Jain.
- (iii) Meanwhile the process of discipline committee, Parents of Mr. Siddhant Jain & Mr. Robin Singh counselled them for forgiving each other. Thereafter Mr. Siddhant Jain and Mr. Robin Singh had withdrawn their complaint.
- (iv) Therefore, Discipline committee stopped its further enquiry as a result didn't reach for any concluding stage due to withdrawing the case from both the parties.

Recommendations:

- (1) Although Mr. Siddhant Jain and Mr. Robin Singh had withdrawn the case but they should be given warning for not committing such act in future and Committee recommends to take an undertaking from them for not committing any mistakes again which come under purview of Indiscipline.
- (2) Although Parents of Mr. Siddhant Jain & Mr. Robin Singh were present during the enquiry of discipline committee however Committee recommends sending a letter to the parents of Mr. Siddhant Jain & Mr. Robin Singh describing about the misconduct/act/involvement in indiscipline act.
