Minutes of the 7<sup>th</sup> Meeting of the Academic Council of JK Lakshmipat University held at JK Lakshmipat University, Near Mahindra SEZ, Mahapura, Ajmer Road, Jaipur on Thursday 21<sup>st</sup> May, 2016 at 11.00 A.M.

1. The Chairman extended welcome to all the members and informed that the Academic Council has been re-constituted and new members as follows have been inducted:

He formally welcomed the two new members Mr. M. M. Singh and Mr. Bijay Sahoo present in the meeting.

The Chairman also informed the Council that out of the two internal members of the Council, Dr. Amit Jain of Institute of Management has since resigned and has been replaced by Dr. Kapil Arora. Dr. Sandeep Kumar Tomar of the Institute of Engineering has been replaced by Dr. SC Bhaduri a senior Professor from the Institute. He also welcomed the two newly inducted internal members.

Academnic Council acknowledged the contributions made by outgoing members and recorded its appreciation.

In his opening remarks the Chairman gave an overview of the activity mix of the University for the year 2015-16 as well as the way forward for 2016-17. He acknowledged the efforts of the previous Vice Chancellors, Directors and all others concerned for getting the university to its present level.

2. Leave of absence was granted to Dr. Mangesh G. Korgaonker, Prof. S. K. Koul, Prof. Asha Bhandarker, Dr. Amit Bardhan, Mr. Sanjeev Kumar Gupta and Mr. C. Vasudevan.
3. Minutes of the last Academic Council Meeting held on May 28, 2015 were noted and confirmed.
4. Action Taken Report based on the Minutes of the last Academic Council Meeting held on May 28, 2015 was noted.

#### **Presentation on Academic Activities by Director-IM**

5. The Director Institute of Management gave a presentation. This included performance of the students, placements, activities, seminars and conferences conducted by the Institute, publications by faculty, MDP's and progress in admissions. He also informed that 3 Students were proceeding for International internship to St. Cloud State University, United States this year.

the members enquired the availability of faculty based on the approved strength for all the programmes presently being offered by the Institute. It was pointed out that starting new programmes would require additional faculty and highlighted the importance of maintaining required faculty:student ratio for recognition, approvals by statutory bodies and accreditations.

The members recommended exploring funding through Department of Science and Technology, other government agencies and industry for funding of incubation centre.

Academic Council suggested that the Director may explore joint opportunity of IOT and potential of Vocational skill development through interfacing with industry.

#### **Tabling of Minutes of Fourth Board of studies Meeting**

9. The members reviewed the course outlines of both the Institutes.

The sample model outline for MBA Semester-I was appreciated by the members and it was suggested that the Institute should work on similar lines and update the courses across all programmes.

For Engineering while approving the course outline of Semester-I, since the course outlines were found to be heavy and needed a fresh look given the contemporary industry requirement, a thorough revision was recommended. The review may incorporate insights gathered from National and International institutions of repute offering similar programmes.

Introduction of UGC scheme of Choice based credit system and interdisciplinary subjects which includes creative arts, humanities and music may also be considered for inclusion to facilitate an all-round development of the student.

Experts from outside/corporate could be invited for delivering modular lectures as fractural courses of 1 or 2 credits.

The members suggested introduction of courses and programmes that are industry relevant like "Virtual Reality", "Mechatronics", "Material science" Robotics etc. Augmenting various courses with ICT inputs and facilitation of learning by doing through incubation centre would also help.

It was also suggested that the University may review the UPSC syllabus for Engineering of various entrance exams and align the university syllabus accordingly.

The members also felt that Academic Council should spare more time to discuss Academic issues rather than discussing admissions, placement and other non-academic issues.

In view of the seriousness of the issue it was resolved to schedule one more meeting on 20 August, 2016 to discuss the academic agenda. The revised syllabus for rest of the semesters after considering the suggestions of the members will be tabled for consideration in the next meeting.

10. Faculty to be encouraged to facilitate use of lectures on website through MOOC and EdX to guide students. They should also be encouraged to enroll for lectures offered through GIAN like schemes to equip themselves well to be better teachers.
11. The members also suggested exploring introduction of additional programmes like Liberal Arts, Law etc.

**Tabling of results of the students to be Convocated this year.**

12. The members enquired if the pre-Ph.D course work was approved by the Academic Council for the students who are being recommended for award of degree. It was clarified that the pre-Ph.D course work for the students admitted in 2011 was tabled and approved in the First Academic Council meeting held on September 03, 2012.

The members suggested tabling of the course outline of Ph.D syllabus complying with the UGC norms for award of Ph.D in the next meeting.

The Gold medal Best Student in the respective Programme is given for one student from MBA and one student from all the programmes of B.Tech.


### **Tabling of amendments to Regulations for the Examination**
