
**Disciplinary Committee** constituted vide Office Order No.140 dated December 6, 2018 is reconstituted as under:

## Details of Minutes of Meetings


September 26, 2019

A meeting of Disciplinary Committee held on 26/09/2019 at 4.30 pm. Following were present:




The committee also observed that, Officiating Registrar, as an immediate interim disciplinary action, removed both the students from Hostel and called their parents for meeting.

Both the boys were made to vacate their hostel accommodation on 14.08.2019 and were handed over to their respective parents/local guardians after completing the formalities.


The committee perused the application and also took note of the interactions of the parents with Registrar, Deputy Registrar & GM Administration.

Looking to the details of the case, the Committee ratify the decision of the Officiating Registrar in such that both the students i.e. Mr. Raghav Bansal and Mr. Jay Majeji should not be allowed further to continue as Hosteller Student, however, since they are in their final year UG Programme, they should be allowed to complete their Programme as Day-scholar. Further, following restrictions will also applicable:

1. They are not allowed to participate in any extracurricular / co-curricular activity.
2. They will not be allowed to stay in campus beyond normal class-room hours.
3. Also they are not allowed to use Gym, Music Room or any other play grounds.
4. Their minimum attendance bar is raised to 85%.
5. On any incidence of indiscipline in future, they will be expelled from the University.


