As you are aware, Choice-Based Credit System (CBCS) is one of the much needed reform initiatives in the higher education sector in India. Though it has already been implemented by several Universities, the diverse evaluation system followed by them does not facilitate the mobility of students across the institutions. **The UGC, in order to mitigate this problem, has formulated guidelines for the Introduction of Choice Based Credit System which are available on UGC website i.e. [www.ugc.ac.in](http://www.ugc.ac.in) needs to be followed in its entirety to ensure uniformity.** The UGC has already written to all the Universities with the hope that the Universities will make necessary preparation for its implementation from the ensuing academic session so that smooth transition of the students amongst Universities can take place.
