He requested them to review the curriculum keeping in view the current trends in the industry and society. He mentioned that the management education is a multidisciplinary programme which needs constant updations in sync with the changing industry trends. The University looks upon the experts from Industry and academia for their guidance and support towards this activity. He further mentioned that Institute of Management goal is to develop foresight, skills and provide practical dimension to our overall course curriculum.

Dr. M.K. Bhatia, Associate Dean- IM also welcomed the members of BoS and shared his vision and goal of taking Institute of Management, JKLU forward. Before beginning the proceedings, he introduced the new members to the BoS. Dr. K. Anandi, CII Institute of Logistics & Mr. Harjeet Singh, EduEdgePro Private Ltd. were the new members to be included in the current BoS.

Minutes of previous meeting were approved by the members.

The draft syllabi of MBA (FT) Batch 2017-19; BBA+MBA (Dual Degree) Batch 2017-22 and B.Com.(Hons)+MBA(Dual Degree) Batch 2017-22 prepared by the Faculty Council were tabled for discussion by the members of the Boards of Studies.

MBA (Full Time) Programme

- 1. At the onset, the Board Members were informed regarding the Three Meetings of Academic Council which were held between the last BoS Meeting of April 16, 2016 and the current one, i.e., on March 18, 2017.
- The MBA Coordinator informed the Board about the Syllabi Benchmarking Exercise carried out during the months of September to December, 2017 and the major changes brought out in the MBA Curriculum. The Board members appreciated the work of Faculty – IM in bringing about the changes and approved the same.
- 3. The Board Members were further informed above separation of codes of Economics subjects as "EC" and introduction of new Code of Entrepreneurship as "EP".
- 4. The Associate Dean IM informed the members about the new "Super" specializations to be introduced by the Institute of Management, viz., Financial Analytics (FA), Retail Management (RM), Logistics & Supply Chain Management (L&SCM), and Digital Marketing & Web Analytics (DMWA). These would be introduced as standalone specializations from AY2017-19 onwards in addition to the Dual Specializations being offered in Finance, Marketing, Human Resources, Operations Management, Information Technology and International Business. Two of them, FA and L&SCM are being introduced with Industry Collaboration of Moody's Analytics & EduEdgePro and CII-IL, respectively. For the remaining two, i.e., RM and DMWA, search is still on for suitable partners.
- 5. In view of above, item no.6 on pg.6 of MBA 2017-19 curriculum would be deleted which talked about the dual specialization being offered with new specializations. Further, the title page needed to be modified to remove words "MBA in..." to reflect the above status.
- 6. The MBA Coordinator requested the Champions and the industry partners for the new specializations to provide the detailed course curriculum in line with the approved detailed structure of these specializations at the earliest and not later than March 28, 2017. Incase, the detailed curriculum for these may not be available, they may not be included for the purpose of Academic Council.
- 7: The Board Members cautioned about the prerequisites for these "Super" specializations, particularly Financial Analytics and Logistics & Supply Chain Management. According to them, additional inputs may be required for these students before they went for summer trainings after MBA first year in sponsored industries by associated industry partners.
- 8. Mr. Dumblekar talked about the need to focus on Logistics and SCM businesses in L&SCM specialization subjects while Mr. Athwal asked that knowledge about how to draw up the contracts should be included in the same. Further, it was suggested to drop the course on "Supply Chain Information System" and replace it by a more relevant subject.
- 9. According to Associate Dean IM, talks were on with relevant industry leaders for tie-up for the remaining two specializations of RM and DMWA. Mr. Dharmendra volunteered to provide some references for industry tie-up for the RM Specialization.
- 10. Mr. Dumblekar suggested to incorporate course on "Digital Marketing for SMEs and Entrepreneurs" in the Marketing Specialization Area.
- 11. Regarding the introduction of the new courses in the MBA core structure, it was proposed to drop the word "Policy" from the title of "EC06 Macroeconomic Theory & Policy", a core subject in MBA Semester II.
- 12. Dr. Vinay Asthana, faculty in abstensia, was required to updated the course of "GN06 Strategic Management", a core subject in MBA Semester IV in consultation with Mr. Dumblekar.

BBA + MBA (5 Years) Dual Degree Programme

- 1. The BBA Program Coordinator informed the Board about the Syllabi Benchmarking Exercise carried out during the months of September to December, 2017 and the major changes brought out in the BBA Curriculum. The Board members appreciated the work of Faculty IM in bringing about the changes and approved the same.
- 2. The BBA Program Coordinator informed the members about the new specializations in the BBA Program viz., Logistics & Supply Chain Management (L&SCM), Banking and Finance (B&F) and Retail Management (RM). The Board members appreciated and approved the new Specializations.
- 3. The Board members suggested that the Four 1-credit courses of Soft Skills with subject codes LS05, LS06, LS07 and LS08 to be replaced by a workshop on Soft Skills and to be conducted as a part of the subject "Business Communication (LS03)" by the Soft Skill trainer.
- 4. The members suggested renaming certain subjects of B.B.A. with "Banking and Finance" as follows:
 - a. The subject "Introduction to Capital Markets" with course code FN17 is renamed as " Capital Market Fundamentals"
 - b. The subject "Introduction to Financial Planning and Wealth Management" with course code FN18 is renamed as "Financial Planning and Wealth Management".

- 6. The members suggested renaming certain subjects of B.Com (H) with Entrepreneurship specialization as follows.
 - a. The subject " Introducing the Entrepreneur" with course code EP04 is renamed as " "Introduction to Entrepreneurs"
 - b. The subject "Managerial Aspects of Small business" with course code EP07 is renamed as "Managerial Aspects of Entrepreneurship".
 - c. The subject "Contemporary policy and Institutional Framework" with course code EP08 is renamed as "Entrepreneurship Policy and Institutional Framework".
 - d. The subject "The Practice of Sustaining and Growing" with course code EP09 is renamed as "Entrepreneurship Practice of Sustaining and Growing"
 - e. The subject "Trends in Entrepreneurship" with course code EP10 is renamed as "Emerging Trends in Entrepreneurship"
 - f. The subject "Business Project" with course code EP11 is divided in two parts and renamed as "Simulation Entrepreneurship Project-I" with course code EP11 in V
